8. In accordance with Pennsylvania Election Code, 25 P.S. § 3261(b), Petitioners have caused the sum of \$50.00 in cash to be posted with the Bucks_____ County Prothonotary, in support of this petition.

9. In accordance with Pennsylvania Election Code, 25 P.S. § 3263(a), the within petition was filed within five (5) days of the completion of the computational canvassing of all returns of the county by the county board.

WHEREFORE, the Petitioners herein respectfully request that their Petition to Open Ballot Box and for Correct Recount Pursuant to 25 P.S. § 3261(a), and as mandated therein, be granted.
