

RightForBucks Special Report

Summary and Status 2.27.2023

RightForBucks issued a [Special Report](#) Jan. 12th 2023 on the **institutionalized corruption, unethical business practices, scandalous bylaws shenanigans by the county committee and election rigging by the Bucks County GOP Establishment. See the full report on our website www.RightForBucks.com.** The report details the accusations levied against Bucks GOP chair Pat Poprik in a formal [Ethics Complaint](#) filed on January 9th, 2023.

The Special Report reveals the following facts about the Bucks GOP:

1. The Bucks County Republican Committee operates under a ***corrupt set of bylaws*** that were designed to concentrate power in the hands of the party leader and a close group of appointed deputies known as “Executives”. They do not comply with the PAGOP bylaws as required by law. They were designed so that they could never be changed and to prevent any political outsiders from ever gaining control of the party.
2. The bylaws bestow the coveted power of making ***endorsements not with the rank and file elected committee members***, but with the cabal of appointed “Executives” who serve at the will of Pat Poprik and choose the winners and losers of the primary elections. The county chair’s *hand-selected and unelected deputies pick your elected officials*. They pick your general election candidates. It’s a ***Candidate Selection Racket***.
3. In response to the Special Report or the formal Ethics Complaint, the ***bylaws on file with the Bucks County Board of Elections suddenly and mysteriously changed*** after decades! It is likely that a counterfeit or illegitimate copy had been submitted to the county and were on file for over a decade before the recent midnight switch back to the 1972 original version. RightForBucks filed a Right To Know request and we were lied to by a county official who signed an affidavit that there have been no changes. A county official appears to have perjured him/herself to prevent the public record of the Bucks ***GOP BYLAWS SWITCH*** to be acknowledged and documented. We have the BEFORE and AFTER time-stamped copies to prove it in our Special Report!
4. A ***formal Ethics Complaint*** has been filed by **nearly 50 committee members** with Pat Poprik’s hand selected Bucks GOP Ethics Committee Chair Joe Pizzo. Mr. Pizzo is also an officer of the county committee and served as Pat Poprik’s perfunctory parliamentarian on June 25th, 2022 at the county election where the candidates Ms. Poprik and Mr.Pizzo

did oversee their own election. The Ethics Complaint has gone UNADDRESSED OR ACKNOWLEDGED by Mr. Pizzo since 1/9/23.

The complaint alleges the following:

- a. Pat Poprik appointed scores of new committee people after the 2022 primary who then voted for her, many by unverified mail-in ballot proxies days later. This is blatantly unethical and an unquestionable ballot harvesting operation.
 - b. Three “mules” carried in 100 proxy votes nearly 25% of the voting total.
 - c. Pat Poprik did oversee her own election.
 - d. The county bylaws and Robert’s Rules of Order were violated at this election.
 - e. Pat Poprik has allowed the county committee to tolerate hundreds of empty seats for a decade prior to her re-election bid. Meanwhile the bylaws give empty seats a vote for her and the status quo.
 - f. Pat Poprik or PAGOP Chair Lawrence Tabas can change the non-compliant bylaws with the stroke of their pen but she likes them the way they are and will not seat committee people who will vote for change.
5. PAGOP Chair ***Lawrence Tabas has been notified of the non-compliant BCRC bylaws*** and is tasked with upholding his duties as party chair to bring the Bucks GOP bylaws into compliance with the PAGOP bylaws and the Pennsylvania Election Code. The law REQUIRES county committee bylaws to be consistent with their state party’s own bylaws. The Bucks GOP bylaws are NOT consistent with the PAGOP bylaws.

RightForBucks provides detailed requests for changes to the BCRC bylaws. We simply ask for structural reforms that will free us from the bondage of a ***corrupt legacy system*** and allow for ***open and fair primary elections***. We want the **DULY ELECTED PRECINCT COMMITTEE PEOPLE** to be the voice of the voters. We want to REMOVE the unelected RUBBER STAMPING APPOINTED EXECUTIVES from the process of endorsing candidates.
